**Sir/Madam,**

With reference to the aforementioned subject, it is hereby stated that the CBSE has initiated the online application window for affiliation under various categories for the session 2026-27. Accordingly, it is imperative to adhere to the CBSE Affiliation process outlined below & complete the process of CBSE affiliation of non-affiliated EMRSs in your state before 31<sup>st</sup> March, 2025.

The following process must be adhered to for the CBSE Affiliation-

1. Application for CBSE Affiliation is to be made online through SARAS portal.
2. It is to ensure that the process for CBSE Affiliation must be initiated one year prior to start of class IX in that particular EMRS (e.g. – if class IX is to be started in the academic session 2024-25 then affiliation process must be initiated and completed in academic session 2023-24).
3. The school must have its own website.
4. For fresh affiliation, the school is required to apply for CBSE Affiliation under the **Government School Category** by clicking on the following link- <https://saras.cbse.gov.in/SARAS/Home/LandingNewGovt>
5. For Upgradation/Extension, the school is required to refer to the following link- <https://saras.cbse.gov.in/SARAS/Home/LandingExistingGovt>
6. Schools seeking fresh affiliation (switchover from other boards) should apply using the following link- <https://saras.cbse.gov.in/SARAS/Home/LandingNewGovt>
7. The timeline for various categories of affiliation for the session 2026-27 is provided at **Annexure-I**.
8. Details of Principal & Staff and high-resolution photographs & videos of school infrastructure where the school is running at the time of CBSE application process with caption, the same is required to be uploaded on the SARAS Portal and on School website too.
9. Schools affiliated under the Middle-Class category must apply for upgradation to the Secondary/Senior Secondary level within five years of their affiliation (Refer to **Annexure-II** for details).
10. All existing CBSE-affiliated EMRSs must ensure that their OASIS data is updated (refer **Annexure III**). No wrong information may be furnished in the OASIS.
11. Uploading of prescribed documents as per Annexure-IX along with the details of teachers and their qualification on school's website under Mandatory Public Disclosure is compulsory as per CBSE Circular (Refer to **Annexure-IV**).

12. All existing schools intending to apply must also complete SQAAP as this is mandatory requirement for applying. The SQAAP portal link is: <https://saras.cbse.gov.in/sqaa/login/Login>
13. Introduction of Additional Subject (schools seeking approval for non-science subject should update the data in OASIS Portal and offer the subject as per norms of the Board.
14. Schools which are due for extension (whose affiliation is valid upto 31<sup>st</sup> March 2026 of the following year) or whose extension is long pending need to apply for extension first, only then they will be allowed to apply under any other category.
15. The suggested formats of essential documents required for uploading when applying for CBSE affiliation of a school through the SARAS portal are attached herewith as **Annexure-V**. In case of non-submission of these essential certificates as per the suggestive format, the application shall be rejected by the board.
16. The list of EMRSs that are required to apply for fresh affiliation upto Secondary/Senior Secondary level is attached herewith as **Annexure-VI**.
17. The list of EMRSs requiring an extension of affiliation is attached herewith as **Annexure-VII**.
18. The list of EMRSs requiring upgradation to the Secondary/Senior Secondary level is attached herewith as **Annexure-VIII**.
19. After receiving CBSE Affiliation letter, details of schools are to be furnished on OASIS portal of CBSE within 15 days of receipt of letter failing will attract penalties to be borne by the school.

In view of the above, State Nodal Officers are requested; (i) to direct all the respective EMRSs in the State to apply for switch over in case of State Board affiliation, or fresh CBSE Affiliation in case of newly functional schools with immediate effect; (ii) ensure that pending EMRSs complete the process of self-assessment on the SQAAP Portal, as this is mandatory requirement for applying; (iii) instruct eligible EMRSs to upload the necessary documents in the suggestive format on the SARAS Portal so that CBSE can process the affiliation procedure without any delay.

**Subject: - Updating of Online Affiliated School Information System (OASIS) data- reg.**

The CBSE affiliated schools are expected to update their Online Affiliated School Information System (OASIS) data every year except the information pertaining to land and section details. This OASIS data maintained by the Board is used for various activities including examination, result processing and framing policies of the Board, as it is the major source of information of the affiliated school across the country.

The information sought in OASIS has been streamlined by adding certain more fields. However, it has been noticed that some affiliated schools are not updating OASIS data regularly or submitting incorrect data which is leading to wrong or incomplete data with Board and also causing financial burden such as penalty on the schools.

In order to avoid such kind of deviation by the school, it is hereby requested to update Online Affiliated School Information System (OASIS) data before the beginning of next academic session. In case if any schools wants to change / correction in land or wants section increase, if any may apply for the same when the SARAS portal is open.

### **Further , as per affiliation By-Laws -**

**Rule 9.3.1 :** *The Manager/Correspondent will be an important and necessary link between the Trust /Society and the School. He/She shall be responsible for carrying out the instructions of the Board.*

The Manager of the School is an important point of communication for carrying out the communication given by Board's instructions. Therefore in order to enable the Board to have an efficient communication with the Manager of the school on the issues pertaining to the affiliation and other ancillary activities, a new field of contact details school manager has been added to OASIS. All of the Schools, are therefore required to submit the correct contact details of the Manager of the School while updating the OASIS data.

Ref: CBSE Circular Nos. CBSE/AFF/03/2021 dt. 05.03.2021 and CBSE/AFF/09/2021 dt. 21.05.2021 (copies attached).

Sir/Madam,

The Board vide Circular No. 03/2021 dt. 05.03.2021 (Sl. No. 3 Clause 2.3.8 and Sl. No. 5 Clause 2.4.9) had issued directions to all affiliated school to develop their own individual website and shall upload details of teachers with qualifications as well as prescribed information and documents as part of Mandatory Public Disclosure, according to the format given in the cited circular, under Appendix-IX.

The Board, vide Circular No. 09/2021 dt. 21.05.2021, once again directed to schools to comply with the above provisions within a period of one month, failing which the Board shall be constrained to take necessary action against the erring schools as per provisions mentioned in Chapter 12 of CBSE Affiliation Bye-Laws, 2018.

However, inspite of the repeated directions by the Board, it has been observed that many affiliated schools still do not have a functional website. Besides, some schools though have a school website but have either not uploaded or partially uploaded the desired information and documents, under Mandatory Public Disclosure.

In some cases, it is observed that schools have though uploaded the desired information/documents but the links to these documents are inactive. Few schools have although uploaded the prescribed information/documents, but the icon/link of the same is not prominently displayed on its Main Home page.

Therefore the Board is giving **one final opportunity to all affiliated schools who have not yet complied with the above instructions**, with a direction to carefully go through both the circulars cited above and upload all prescribed information and documents in an unambiguous and absolute manner **within 30 days of the issue of this Circular**, failing which the Board shall be constraint to initiate necessary-proceedings and imposing penalty against the erring schools as per Chapter 12 in accordance with Chapter 13 of Affiliation Bye-Laws, without any further reminder.

Those schools who have apparently complied with the given directions are also instructed to re-visit their website and verify the uploaded information & documents vis-a-vis the directions given herein in the light of the cited circulars. In case of any disparity, the same ay be updated immediately.

To bring the transparency and build up trust among the stakeholders, CBSE has been giving emphasis on "Mandatory Public disclosure" of relevant information by its affiliated Schools. This information has to be displayed on the schools website as per clause 2.4.9 of Affiliation Bye laws 2018, as per the format prescribed in Appendix IX of Circular dated 05/03/2021.

The format of Mandatory Public Disclosure along with the relevant circular is once again attached for ready reference.

The schools are informed to display the same on the Home page itself of the school website under an icon "Mandatory Pubic disclosure". **The icon link so posted on the schools' website should be distinctly visible for easy accessibility.** It is important that this information is easily accessible to the public and therefore the link on the website should be prominently displayed.

In this connection, it has been observed that inspite of clear directions from the Board, some of the schools are not following these provisions. It is therefore, reiterated that it is imperative on the part of the schools to comply not only with the provisions of State Education department but also with the provisions of the Affiliation and Examination Bye-Laws of the Board, to bring transparency and easy accessibility by stakeholders.

The Central Board of Secondary Education has also made it as a mandatory pre condition for granting or extending affiliation. The School leaders and Managers of the schools are directed to take note of the above condition and comply with the provisions mentioned in circular dated 05.03.2021. If it has not been complied with already, the same may be done within a period of one month failing which the Board will be constrained to take necessary action as per provisions mentioned in Chapter 12 of Affiliation Bye-Laws, 2018.
